What is the COST project




- **A platform to meet and discuss research ideas**
- **Usually 4 years**
- **Min 7 countries (at least 50% from Inclusiveness Target countries)**
- **provides funding for research coordination and capacity-building activities, not research itself**
- **No budget forecast is requested when submitting a proposal**







Mobility of researchers and innovators

Short-Term Scientific Mission
Visit of a host organization located in a different country than the country of affiliation by a Researcher or Innovator for the specific work to be carried out and for a determined period of time. The grantee receives funding for implementing a project with an international team and gains new knowledge or access to equipment or techniques not available in the home institution.

Financial support for Researchers or Innovators (with a primary affiliation to an institution located in a COST Full or Coordinating Member country or from a COST Near Neighbour Country) to foster collaboration in a virtual setting, to exchange knowledge, learn new techniques, etc.

Young Researcher and Innovator Conference







MORE ABOUT PROPOSAL



- No budget draft/information is needed in the proposal
- Proposers are individuals (and not their entities of affiliation)
- Use and don't change the template for Technical Annex
(Documents and Guidelines on the COST website)
- Be careful about anonymity
- submit draft in advance (e-COST allows resubmission)



Finances



- funded through a grant to the COST Action Grant Holder (GH) institution elected at the 1st Management Committee meeting.
- The Grant Holder institution can retain up to 15% of the scientific expenditures of the Action for Financial and Scientific Administration and Coordination (FSAC). This amount is therefore variable and can be used for the execution of the financial and administrative coordination tasks



Useful tips

The COST Association strongly recommends complying with the following requirements when drafting a proposal:

- present the text in a logical way, avoiding unnecessary repetition between the different sections;
- do not use footnotes, explain all acronyms;
- use of capital letters for COST-specific and Action-related expressions such as: COST Action, Action Chair, Action Management Committee, Working Group, Short-Term Scientific Mission (STSM), Training School, Core Group



Useful tips



- avoid pronouns such as “I”, “we”; rather use “the Action”;
- avoid expressions such as “planned” or “proposed” when referring to the Action; rather use “aims at”, “will”, etc.;
- avoid overstatements regarding the potential impact of the Action
- special note on anonymity: To be eligible, a proposal shall be anonymous, hence contain no direct or indirect reference to proposers and/or institutions participating in the network of proposers, meaning that proposers’ and/or institutions’ names should neither be explicitly mentioned nor be potentially identifiable.

FAQ



- **Deadline of the next call? - 21 October 2025 12:00 CEST**
- **Who is an applicant? -** An applicant is a person (not an institution) affiliated with a legal entity in Europe
- **Can we have more than 2 proposers from the same institution? -** Yes, there is no limitation on the number of proposers from one institution.
- **How will the main proposer invite the second one to participate in the proposal? -** That happens via e-COST, where you can fill in an email address and send the invitation to the secondary proposers.

FAQ



- **Can we re-submit the proposal if it's not successful in the upcoming round?** - Yes. resubmissions are possible. No restrictions.
- **The chances to be selected are higher, if the main proposer is a young researcher, from an ITC, and of the underrepresented gender?** These can be criteria, along with the COST Excellence Policy specific objectives, for selection by the Scientific Committee. The chances may not necessarily be higher.

FAQ



- **If no budget is needed in the submission, how can we know what will be funded in our proposal?** Without a budget, this means that you are proposing a 4-year plan of activities. If the proposal is successful and becomes an action, you will negotiate a work plan and budget each year detailing activities for the coming year. For a proposal, it is worth considering that the total budget will be in the range of 600 000 euros over four years.
